### **GRANT OF SHARE OPTIONS**

This announcement is made pursuant to Rule 23.06A of the Rules (the “**GEM Listing Rules**”) Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board (the “**Board**”) of directors (the “**Director(s)**”) of Shen You Holdings Limited (the “**Company**”) hereby announces that, on 31 August 2022 (the “**Date of Grant**”), the Company resolved to grant an aggregate of 8,000,000 share options (each a “**Share Option**”) under the share option scheme (the “**Share Option Scheme**”) adopted by the Company on 24 November 2017 to certain Directors (collectively, the “**Grantees**”) to subscribe for an aggregate of 8,000,000 ordinary shares of HK\$0.05 each in the share capital of the Company (each a “**Share**”), subject to the acceptance of the Grantees (the “**Grant**”).

As at the Date of Grant, the Company has 409,141,860 Shares in issue. The total of 8,000,000 Shares to be subscribed under the Share Options granted represent approximately 1.96% of the existing issued share capital of the Company as at the Date of Grant and approximately 1.92% of the enlarged issued share capital of the Company assuming full exercise of the Share Options.

- (iii) the nominal value of HK\$0.05 per Share.
